NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **situate at the north-east corner of the intersection of Wallace Street and Whiting Street in Greenville Township, Greenville County, and being shown and designated as Lot 103, Section 2 of Dunean Mill Village, recorded in Plat Book S at Page 175, and, having according to said plat, the following metes and bounds, to-wit:**

BEGINNING at an iron pin on the northeast side of Wallace and Whiting Streets and running thence with the northeast side of Whiting Street N. 65-12 W. 131.4 feet to an alley; thence with said alley, N. 54-26 E. 82.2 feet to pin; thence S. 64-22 E. 132.9 feet to pin on Whiting Street; thence with the northwest side of Whiting Street S. 25-38 W. 80.1 feet, to the beginning corner.
