WHEREAS, the Mortgagor is well and truly indebted unto LAURENS FEDERAL SAVINGS AND LOAN ASSOCIATION, LAURENS, S. C. (hereinafter referred to as Mortgagee), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-seven Hundred and No/100 DOLLARS (\$ 8700. 00), with interest thereon from date at the rate of

six and one-half

($6\frac{1}{2}$) per centum per annum, said principal and interest to be repaid as therein stated, except that the final

payment of principal and interest shall be due on September 1, 1983, and

WHEREAS, the Mortgagor, may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, being Lot 19 of B. F. Reeves Subdivision on plat by H. S. Brockman, September 14, 1953, recorded in the R. M. C. Office for said County in Plat Book 00 at page 190, described as follows: BEGINNING at iron pin at intersection of Hips Avenue and Gary Avenue, running along Hips Avenue on line of Lot 19 North 4-46 East 187.6 feet to iron pin at corner of Lot 59, thence along line of Lot 59 North 69-05 West 61 feet to iron pin at corner of Lot 20, thence along line of Lot 20 South 21-30 West 180 feet to iron pin on Gary Avenue, thence along Gary Avenue South 69-05 East 115.2 feet to the beginning.

The foregoing lot was conveyed to mortgagors by deed of Cecil H. Fowler, July 16, 1963, to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
