All that certain piece, parcel or lot of Land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, situated on the west side of the Jordan Road, near Jordan School, containing 46 acres, more or less, bounded by lands now or formerly belonging to Hilton Babb, J.A. Herman and others, and being the same property conveyed to the mortgagor herein by E. Inman, Master, by deed recorded in Deed Book 573, page 525, R.M.C. Office for Greenville County.

This is the same property also referred to in deeds recorded in the R.M.C. Office for Greenville County in Deed Book 573, at pages 491 and 492.
