All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 8 as shown on a plat prepared by J. C. Hill dated August 3, 1959, entitled "Property of J. C. Hughes"**, recorded in the R.M.C.
