NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and aum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN. ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted bargained, sold and released and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 47 of an Extension of Section One of Brookwood Forest as shown on a plat thereof prepared by C. C. Jones, C. E., February 13, 1963, and recorded in the R.M. C. Office for Greenville County in Plat Book XX, at Page 96, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Charing Cross Road, joint front corner of Lots Nos. 46 and 47, and running thence along the joint line of said lots, N. 63-13 W. 142 feet to an iron pin; thence N. 26-14 E. 123.5 feet to an iron pin; thence S. 58-20 E. 154 feet to an iron pin on the western side of Charing Cross Road; thence along the western side of Charing Cross Road, S. 31-40 W. 87.5 feet to an iron pin; thence continuing along the western side of Charing Cross Road, S. 30-20 W. 22.5 feet to the beginning corner; being the same conveyed to us by Mauldin Construction Co. by deed of even date to be recorded herewith."

In addition to the above mentioned monthly payment of principal and interest payable under the terms of the note secured hereby, the mortgagor(s) agree(s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgagee in escrow to pay said premiums, taxes and special assessments. Should these payments exceed the amount of payments actually made by the mortgagee for taxes, assessments, or insurance premiums, the

excess may be credited by the mortgagee on subsequent payments to be made by the mortgagor(s); if, however, said sums shall be insufficient to make said payments when the same shall become due and payable the mortgagor(s) shall pay to the mortgagee any amounts necessary to make up the deficiency.
