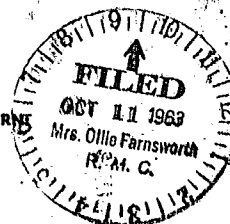

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN



WHEREAS, Leon Boyd and Kathleen Boyd

(hereinafter referred to as Mortgagor) is well and truly indebted unto J. R. Richardson, Sr. and Jeff R. Richardson, Jr.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Hundred Seventy-five and no/100 - - - - - Dollars (\$ 1575.00) due and payable Twenty-five Dollars (\$25.00) a month beginning the 10th day of September, 1963 and Twenty-five Dollars (\$25.00) a month on the tenth day of each successive month thereafter; said payments to be first applied to interest and then to principal with the entire principal balance being due one year from date.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of and being known and designated as lot No. 18 on a plat entitled Revised Map No. 1 of Franklin Hills Subdivision dated May, 1963, by C. O. Riddle, L. S. being recorded in Plat Book DB at Page 95 in the R. M. C. Office for Greenville County, reference to said plat being made for a further metes and bounds description.
