Fifty and No/100 - - -) Dollars upon the first day of 50.00 (\$ ... each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 11-7/12 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of Glenn Farms Road, being known and designated as the greater portion of Lot 13 and a small portion of Lot 12, Block A of Glenn Farms as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book M at Page 75 and having, according to a plat of Property of Glynn Lindsey prepared by Madison H. Woodward, October 19, 1963, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Glenn Farms Road, joint front corner of Lots 13 and 14 and running thence along the northern side of Glenn Farms Road, N. 83-30 E. 70.4 feet to an iron pin in the front line of Lot 12; thence N. 6-12-E. 104.7 feet, crossing the old joint line of Lots 12 and 13 to an iron pin on the rear line of Lot 13; thence N. 87-30 W. 53 feet to an iron pin at the joint rear corner of Lots 13 and 14; thence along the joint line of said lots, S. 4-30 W. 115.2 feet to the beginning corner; being a portion of the property conveyed to me by Thomas H. Gibbs by deed dated August 3, 1963 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 729 at Page 212."
