WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighteen Thousand Six Hundred and No/100

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Covington Road, shown as Lot No. 113 on plat of Northwood Hills, Section III, as shown on plat recorded in Plat Book YY at Page 37 in the RMC Office for Greenville County, and being further described as

"BEGINNING at an iron pin on the southern side of Covington Road, joint front corner of Lots 113 and 114, and running thence along the line of Lot 114, S. 5-52 E. 183.6 feet to an iron pin; thence S. 69-55 W. 127.6 feet to an iron pin, corner of Lot 112; thence along the line of Lot 112, N. 5-13 W. 171.0 feet to iron pin on the southern side of Covington Road; thence along Covington Road, N. 84-15 E. 125.0 feet to the point of beginning."
