"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs,
Township, on the south side of Crain Drive near Fairview Baptist
Church, and being a portion of Lot No. 17 of the property of John B.
and Mancie N. Crain Estate, plat thereof recorded in Plat Book Y, page
79, R.M.C. Office for Greenville County, and having the following courses
and distances, to-wit:

BEGINNING at an iron pin on the south side of Crain Drive, corner of Lots Nos. 16 and 17, and running thence along the line of said lots, S. 28-37 W. 124 feet to an iron pin, new corner; thence N.73-40 W. 357.6 feet to an iron pin on line of Lot No. 18; thence along the line of Lot No. 18, N. 29-15 E. 205.2 feet to an iron pin on the south side of Crain Drive; thence along said Crain Drive, S. 60-40 E. 350 feet to the beginning corner.
