NOW KNOW ALL MEN, That I'we, the said mortgagor (s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according, to the terms of said note, and also in consideration of the further sum of three Dollars to meyus the said mortgagor (s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted bargained, sold and released and by these presents of grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina County of Greenville, being known and designated as Lot No. 23, Section One of a subdivision known as Brookwood Forest as shown on a plat thereof prepared by C. C. Jones, C. E. dated November 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book XX, at Page 97, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Holborn Lane at the joint front corner of Lots 22 and 23; running thence along the joint line of said lots, S. 1-55 W. 157. 6 feet to an iron pin; thence due West 92 feet to a point in the center of a branch. thence following the center of said branch in a northwesterly direction 162 feet, more or less, to an iron pin on the southern side of Holborn Lane at or near a culvert; thence along the southern side of Holborn Lane, S. 89-05 E. 128 feet to the beginning corner; being the same property conveyed to us by Mauldin Construction Co. by its deed of even date to be recorded herewith.
