WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eleven Thousand and Five Hundred -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, on the north side of the McElhanev Road about one-half mile eastward from Double Springs Baptist Church, having the following courses and distances, to-wit:

BEGINNING at corner of Ernest Mullinax tract, located in center of McElhanev Road, S. 68-45 E. 431 feet from center of Clark Road, and running thence N. 17-20 W. 263 feet to an iron pin; thence N. 74-00 E. 310.4 feet to iron pin, corner of James T. Kemp, Jr. lot; thence with Kemp's line, S. 1-32 W. 417.4 feet to corner in center of McElhanev Road; thence along road, N. 68-45 W. 224.8 feet to beginning corner.
