WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **NINE THOUSAND THREE HUNDRED AND NO/100 -----**

DOLLARS (\$ 9,300.00), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, Bates Township, containing one and one-half (1½) acres, more or less, and being a portion of the Issac Kelley Estate, having the following metes and bounds, to-wit:**

BEGINNING at a stump at the Northeast corner of Virgil Bridges property and the Northwest corner of property of Jerry Hawkins property, which property is in the center of a County road running East from U. S. Highway #25 to the Belle View School House, thence in a northeasterly direction, 569 feet to a point in the center of Belle View Road, thence along the center of said road in a southwesterly direction, 585.5 feet to the center of the first mentioned county road, thence along the center of said road in a southeasterly direction, 350 feet to the point of beginning. This lot is triangular in shape.
