NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel of lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Buckingham Road, shown as Lot 244 on a plat of the Gower Estates, Section B, recorded in Plat Book XX at Pages 36 and 37, being further described according to said plat as follows:

BEGINNING at an iron pin on the Eastern side of Buckingham Road at the joint front corner of Lots 245 and 244 and running thence along the joint side line of said lots, N. 76-41 W. 175 feet to an iron pin at corner of Lot 274; thence along the line of Lot 274, N. 13-19 E. 100 feet to an iron pin at the corner of Lots 275 and 243; thence along the line of Lot 243, N. 76-41 W. 175 feet to an iron pin on the Eastern side of Buckingham Road; thence along Buckingham Road, S. 17-27 W. 100 feet to the beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing; and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
