NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that-certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of the Woodruff Road, containing 1.16 acres, more or less, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the South side of said road at the joint front corner of the Vaughn property, and running thence S.8 W.178.4 feet to an Iron Pin, thence N.85-50 E.270 feet to an Iron Pin, thence N.8 E.178.4 feet to an Iron Pin on the Woodruff Road, thence with said road S. 85-50 W.270 feet to the beginning point. This being the same property which was conveyed to James A. Maxwell and Dorothy F. Maxwell by C. M. Maxwell and Kate S. Maxwell by deed recorded in the R. M. C.
