"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, located about one mile northward from the City of Greenville, on the north side of Sidney Street, the south side of Gantt Street and the southwest side of Laurel Street, and being Lots Nos. 16, 17, and a portion of Lot No. 18 of the J.M. Perry property, plat recorded in Plat Book F, page 127, R.M.C. Office for said County, and having the following courses and distances, to-wit:
