Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, known and designated as Lots 66, 67, and a small portion of Lot 68 of Block D, shown on a plat of the subdivision of MAYFAIR ESTATES, recorded in the R. M. C. Office for Greenville County in Plat Book S, pages 72 and 73, and having the following metes and bounds:

Beginning at a point on the eastern side of Sutton Drive in the front line of Lot 68, which point is 268.3 feet in a southern direction from the southeastern corner of the intersection of Sutton Drive and Lee Road, and running thence along the eastern side of Sutton Drive S 17-17 E 66.66 feet to an iron pin at the joint front corner of Lots 65 and 66; thence along the line of Lot 65 N 72-43 E 168 feet to an iron pin; thence N 16-09 W 66.7 feet to a point in the rear line of Lot 68; thence S 72-43 W 169.3 feet to the point of beginning.
