"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located about three miles northwest of the City of Greer and on the south side of Gail Avenue, being shown as Lot No. 34 in Section 4 of of VALLEYHAVEN ACRES, property of W. Dennis Smith Smith, made by John A. Simmons, Registered Surveyor, dated July 15, 1960, recorded in the R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the margin of said street, joint corner of Lots Nos. 33 and 34, and runs thence with the common line of said lots, S. 52-40 E. 259.6 feet to an iron pin on the southeast side of branch; thence S. 21-10 W. 80 feet to an iron pin; thence N. 89-40 W. 245 feet to an iron pin; thence N. 1-17 E. 195.4 feet to an iron pin on margin of said street; thence with the margin of said street(the chord of which is N. 64-30 E.) 70.7 feet to the beginning corner.
