All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the Northern side of Harvard Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 10 as shown on a plat entitled "Revised Map, Addition to Brookwood", prepared by C.O. Riddle, R.L.S., dated October 30, 1963, recorded in the R.M.C.
