(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee), in the sum of **Five Thousand and No/100** **DOLLARS (\$ 5,000.00)**, with interest thereon at the rate of **Six** percent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or so before, modified by mutual agreement, in writing, the final maturity of which is **15** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and agrees to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, situate on the southern side of West Mills Avenue and being known as Lot 3 of Block F on a plat of O. P. Mills property, recorded in Plat Book C at Page 176 and being more particularly described as follows:

BEGINNING at an iron pin on the southern side of West Mills Avenue, 65 feet west from Ledge Street, and running thence S. 44-33 E. 180 feet to a 16 foot alley; thence with the Northern side of said alley, S. 45-27 W. 65 feet to an iron pin; thence N. 44-33 W. 180 feet to Mills Avenue; thence with the Southern side of Mills Avenue N. 45-27 E. 65 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the trees, books, and profit which may grow or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or articles now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
