each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 25 years after date. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 25 of a subdivision known as Spring Forest according to a plat thereof prepared by Douglas R. Crouch, April, 1963 and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 126, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Spring Forest Road at the joint front corner of Lots Nos. 24 and 25, and running thence along the joint line of said lots, N. 8-52 W. 166.1 feet to an iron pin in the rear line of Lot No. 18; thence with the rear line of Lot No. 18, N. 76-30 E. 10 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence with the rear line of Lot No. 17, N. 82-20 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 16 and 17; thence with the rear line of Lot No. 16, N. 81-35 E. 20 feet to an iron pin at the joint rear corner of Lots Nos. 25 and 26; thence with the joint line of said lots, S. 5-22 E. 168.2 feet to an iron pin on the northern side of Spring Forest Road, joint front corner of Lots Nos. 25 and 26; thence with the northern side of said Spring Forest Road, S. 82-37 W. 100 feet to the point of beginning; being the same conveyed to me by Alvin A. McCall, Jr. by deed of even date, to be recorded herewith."

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments WHENCH WELL WIll be due and payable, such sums to be held by mortgagee in escrow to pay said premiums, taxes and special assessments. Should these payments exceed the amount of payments actually made by the mortgagee for taxes, assessments, or insurance premiums, the excess may be credited by the mortgagee on subsequent payments
