WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Southwestern side of Cleveland Street Extension in the City of Greenville, and containing approximately $2\frac{1}{2}$ acres and being shown as the major portion of Lot 2 on a plat of the property of G. B. Lee recorded in Plat Book 0 at page 105 and being more particularly described as follows:

BEGINNING at an iron pin on the Southwestern side of Cleveland Street Extension, the joint front corner of Lots 2 and 3; thence with the line of Tract 3, S. 64-30 W. 197.7 feet to an iron pin; thence continuing with the line of Tract 3, S. 52-20 W. 235.4 feet to an iron pin; thence with the line of Tract 3, N. 22-52 W. 118.4 feet to a pin at corner of Tract 1; thence with the line of Tract 1 N. 49-19 E. 275.4 feet to an iron pin; thence N. 57-02 E. 162 feet to an iron pin on Cleveland Street Extension, said pin being 22 feet South from the joint corner of lots 1 and 2; thence with Cleveland Street Extension, S. 29-20 E. 98 feet to the point of Beginning.
