# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: **ANNA LOUISE LEWIS**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ten Thousand and No/100-----**

**DOLLARS (\$ 10,000.00** ), with interest thereon from date at the rate of **six-----** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the Southeastern side of Kingswood Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 30 as shown on a plat of Shamrock Acres, prepared by Clifford C. Jones, R.L.S., dated September, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY at page 43, and having according to said plat the following metes and bounds:**

**BEGINNING at an iron pin on the Southeastern side of Kingswood Drive at the joint front corner of Lots Nos. 29 and 30, and running thence with the line of Lot No. 29 S. 55-00 E. 140 feet to an iron pin in the line of Lot No. 32; thence with the line of Lot No. 32 N. 18-22 E. 182.5 feet to an iron pin at the joint corner of Lots Nos. 30, 31 and 32; thence with the line of Lot No. 31 N. 55-00 W. 88.5 feet to an iron pin on the Southeastern side of Kingswood Drive; thence with the Southeastern side of Kingswood Drive S. 35-00 W. 175 feet to the point of beginning.**
