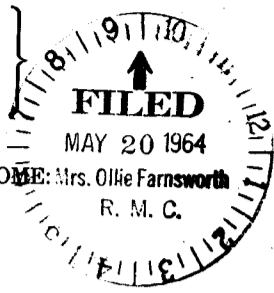

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, containing 2.1 1/2 acres, more or less, being shown on as follows on plat by Hugh J. Martin, September 4, 1963; beginning at iron pin in center of a county road, running in a Southeastern direction down center of said road South 79-34 East 127.8 feet to iron pin, thence South 37-51 West 300 feet along line of J. W. Ridgeway, thence South 65-11 West 100 feet to iron pin, thence South 86-33 West 187.1 feet to iron pin at the C. N. Wright line, thence along the Wright line North 26-30 West 18.5 feet to iron pin at the Marcus Holcombe line thence with the Holcombe line North 67-15 East 431.7 feet to the beginning.
