(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate at the

northwestern corner of the intersection of Dellrose Circle and Cunningham Road in Chick Springs Township and being shown and designated as Lot 1 on plat of Drexel Terrace recorded in Plat Book QQ at page 177 and being more particularly described by metes and bounds as follows:

BEGINNING at an iron pin on the northern side of Dellrose Circle at the joint front corner of Lots 1 and 2 and running thence with the line of Lot 2 S. 3-22 E. 180 feet; thence N. 86-38 E. 160 feet to pin on Cunningham Road; thence with the western side of Cunningham Road S. 12-09 W. 161.8 feet to pin; thence with the curve of the intersection of Cunningham Road and Dellrose Circle, the chord of which is S. 49-23 W. 40.1 feet to pin on Dellrose Circle; thence with the northern side of Dellrose Circle S. 86-38 W. 85 feet to the point of beginning.
