"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situated on the corner of Bessie Avenue and the

J.Wayman Smith Road, near Pleasant Grove Baptist Church, about one mile southward from the City of Greer, Chick Springs Township, and being lot No.50 of Woodland Heights , property of I.M.Wood Estate , according to survey and plat by H.S.Brockman , Registered Surveyor, dated October 28th., 1955, recorded in Plat Book GG page 151 R.M.C.Offive Greenville County, S.C. , and having the following courses and distances, to-wit:-
