Walter H. Robertson of

WHEREAS, the Mortgagor is well and truly indebted unto Aiken Loan & Security Company

organized and existing under the laws of the State of South Carolina, hereinafter

if not sooner paid, shall be due and payable on the first day of July, 1989.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the  
southerly side of Tucson Drive and being shown and designated as Lot No. 9 on plat of Western  
Hills, Section 2, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK"  
at page 130.

Said lot No. 9 fronts on the southerly side of Tucson Drive 181 feet, has a depth of 150 feet  
on the easterly side, a depth of 201.9 feet on the westerly side and is 65.5 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
