Mack Cochran; running thence along the line of S. Mack Cochran, S. 39-30 E. 111.7 feet to an iron pin, joint rear corner of Lots Nos. 26 and 24; running thence with the joint line of said lots, S. 1-33 W. 112.2 feet to an iron pin on the northern side of the turnaround of Strand Court; thence with the northern side of the turnaround of said Strand Court, S. 72-15 W. 47.1 feet to an iron pin; thence continuing with the northern side of said Strand Court, S. 75-24 W. 50 feet to the point of beginning; being the same conveyed to us by John K.
