A. James, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Thirty-two Hundred -----**

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the City of Greer, and being more particularly described as Lot No. 40 on a plat entitled "Subdivision for McCall Manufacturing Company, Greer, S.C.," prepared by Pickell & Pickell, Engineers, Greenville, S.C., dated May, 1949, and recorded in Plat Book S, page 76, R.M.C. Office for Greenville County. This lot is also known as No. 103 Franklin Street (Now Delano Avenue), and fronts thereon 96 feet.
