All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, at the Northwest intersection of Wood Drive and Lawton Avenue and being known and designated as Lot No. Thirty (30) of the J. A. Wood Estate property as shown on plat prepared by John A. Simmons, Reg. Surveyor, dated Feb. 6, 1963 and which plat has been recorded in the R. M. C.
