MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:
We, L. A. Sullins and Mary Elizabeth Sullins,
SEND GREETINGS:
WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-
VILLE, in the full and just sum of <u>Sixteen Thousand</u> , <u>Nine Hundred and No/100-(\$16,900.00.</u>) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se
cured hereby), said note to be repaid with interest at the rate specified therein in installments of
One Hundred Eight and 89/100(\$ 108.89) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal bal ances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently
extended, will be due and payable 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fer beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.
NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of mone aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAM ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receip whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed there

M. C. Office in Plat Book YY, at pages 118 and 119, and being more fully described as follows:

"BEGINNING at an iron pin on the north side of Mimosa Drive, joint corner with lot No. 84 and running thence along said lot, N. 15-00 E. 200 feet to an iron pin; thence S. 75-00 E. 100 feet to an iron pin; thence S. 15-00 W. 200 feet to an iron pin on Mimosa Drive; thence along said drive, N. 75-00 W. 100 feet to the beginning corner; being the same conveyed to us by Florrie V. Greer by deed dated June 18, 1964, to be recorded herewith."
