"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Chick Springs Township, situate on the northwestern senser of the intersection of Bridgewater drive and Yorkshire Drive, and being shown and designated as lot 182 on a plat of Sector IV of Botany Woods recorded in the RMC Office for Greenville County in Plat Book YY at Page 23 and having, according to said plat, the following metes and bounds, to-wit:
