"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the Northern side of Rutherford Road (sometimes called Old National Highway), in the City of Greenville, being the Eastern portion of lot 6 as shown on plat of West Croftstone Acres, recorded in the RMC office for Greenville County in Plat Book El at Page 36, and described as follows:

BEGINNING at a stake at the northwest corner of Rutherford Road and Summitt Drive, and running thence with the northern side of Rutherford Road, in a westerly direction 150 feet to a stake at corner of other property of the mortgagor; thence with the line of said property N. 7-30 W. 264 feet to a stake in line of lot 16; thence with the line of said lot, in an easterly direction N. 76-35 E. 149 feet to a stake on Summitt Drive; thence with the western side of said Drive, S. 7-30 E. 250.4 feet to the beginning corner.
