NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of

Greenville in the Berea Community, and being known and designated as Lot 65 of a Subdivision known as Westcliffe, shown on plat recorded in Plat Book YY at pages 168 and 169, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Westcliffe Way, corner of Lot 109 and running thence N. 8-57 W. 290 feet to an iron pin; thence with the line of Lot 64, S. 62-18 E. 171 feet to an iron pin on the Western side of Folkshire Court; thence with said Court as follows: S. 3-25 E. 45 feet to a stake; S. 23-35 E. 59 feet to a stake; thence S. 10-31 E. 60.8 feet to a stake; thence around a curveto the right, the chord of which is S. 35-15 W. 34.9 feet to a stake on Westcliffe Way; thence with said Way, S. 8-00 W. 125 feet to the beginning.
