"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

Known and designated as Lot No. 53, Section 1, on plat of Rockvale Subdivision recorded in plat Book QQ at page 108 of the R. M. C. Office for Greenville County, South Carolina, said lot having a frontage of 108.8 feet on the west side of Sandra Street, a depth of 106 feet on the south side, a depth of 164 feet on the north side, and a rear width of 76.5 feet.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.
