NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the Eastern side of Dempsey Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 11 as shown on a plat of property of E. A. Smythe, et al, dated November, 1935, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "D" at page 170, and having according to a more recent plat prepared by J. Mac Richardson, dated September 24, 1954, entitled "Property of J. C. Baker and Nancy Baker" and having according to the last mentioned plat, the following metes and bounds:**

BEGINNING at an iron pin on the Eastern side of Dempsey Street at the joint front corner of the premises herein described and property now or formerly of Roy B. Key and running thence with the line of the said Key property S. 71-04 E. 428.6 feet to an iron pin on the line of property now or formerly of E. E. Chapman; thence with the line of the said Chapman property N. 28-13 E. 84.4 feet to an iron pin; thence with the line of property now or formerly of M. H. Wilson N. 71-04 W. 435 feet to an iron pin on the Eastern side of Dempsey Street; thence with the Eastern side of Dempsey Street S. 31-50 W. 84 feet to the point of beginning.
