"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the south, side of Frohawk Creek, near the old City Limits of Greer, adjoining lands of W.I. Moore, Fred Clark and others, and having the following courses and distances, to-wit:-
