"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, containing 4.68 acres, more or less, and being designated as Tract No. 1 as shown on the plat of the property of L. W. Young, dated April, 1955, by C. O. Riddle, Registered Surveyor as recorded in Plat Book No. II, page 119, Office of the RMC for Greenville County, the said tract being more particuarly described by metes and bounds as follows:
