WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ten Thousand and No/100ths**-----

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **at the Northwestern corner of the intersection of Bates Drive and Brooks Drive, Bates Township, Greenville County, State of South Carolina, and having according to a plat prepared by Terry T. Dill, dated August 24, 1960, entitled "Property of C.C. Bates and G.T. Bates", the following metes and bounds:**
