WHEREAS, W. N. Leslie, Inc.

(hereinafter referred to as Mortgagor) is well and truly indebted unto Southern Bank and Trust Company

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 56 of Wellington Green, Section Two, as shown on plat thereof entitled "Revision of Lots 56 & 57, Wellington Green, Sec. 2" by Piedmont Engineers and Architects dated August 22, 1964 and recorded in the R. M. C. Office for Greenville County in Plat Book "HHH", Page 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Newcastle Way at the joint front corner of Lots Nos. 55 and 56 and running thence along the line of Lot No. 55 N. 3-38 E. 165.2 feet to an iron pin; thence along the line of Lots Nos. 67 and 66 N. 63-31 W. 70 feet to an iron pin at the joint rear corner of Lots Nos. 56 and 57; thence along the line of Lot No. 57 S. 21-00 W. 180.7 feet to an iron pin on the northern side of Newcastle Way; thence along Newcastle Way and following the curvature thereof, the chords being S. 74-03 E. 65.2 feet and S. 80-14 E. 55 feet, to the beginning corner.

The above described property is the same conveyed to the mortgagor by deed of Tom S. Bruce, As Trustee by deed of even date herewith to be recorded.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
