"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain lot of land situate, lying and being on the Western side of Orchard Drive, near the City of Greenville, State of South Carolina, being known and designated as Lot No. 205, as shown on a plat prepared by J.
