TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Theodore W. Malphrus and Eugenia R. Malphrus

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Two Thousand and No/100

DOLLARS

(\$22,000.00), with interest thereon at the rate of five and one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeasterly side of Fontaine Road in the City of Greenville, S. C., being known and designated as Lot No. 25, Section 2, property of Elizabeth L. Marchant, as recorded in the RMC Office for Greenville County, S. C., in Plat Book YY, at page 145, and having according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the northerly side of Fontaine Road, said pin being the joint front corner of Lots 23 and 25 and running thence with the common line of said lots N 11-41 E 318 feet to an iron pin, the joint corner of Lots 23, 22, 24 and 25; thence with the common line of Lots 24 and 25 S 88-12 E 180 feet to an iron pin in the line of property now or formerly belonging to R. S. Small; thence S 18-31 E 199 feet to an iron pin; thence S 9-11 W 113.7 feet to an iron pin; thence S 45-53 W 155.5 feet to an iron pin, the joint corner of Lots 25 and 26; thence with the common line of Lots 25 and 26 N 39-39W 126.9 feet to an iron pin on the easterly side of Fontaine Road; thence with the easterly side of Fontaine Road on a curve, the chord of which is N 21-05 W 52.2 feet to an iron pin; thence N 83-05 W 50 feet to an iron pin; thence S 38-21 W 50 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
