I, WILLIAM G. BURNS of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the North side of West Fourth Street near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 49 on plat of Section B of a subdivision for Woodside Mills made by Pickell & Pickell, Engineers, January 14, 1950, recorded in the RMC Office for Greenville County, S. C., in Plat Book W, Pages 111-117 inclusive; said lot fronting 81 feet along the North side of West Fourth Street and running back to a depth of 123.4 feet on the East side, to a depth of 123.1 feet on the West side, and being 81 feet across the rear along a twelve-foot alley.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
