\$25.00 per month until paid in full, plus interest,

with interest  
from date at the rate of SEVEN (7%) per centum per annum  
until paid; interest to be computed and paid annually and if unpaid when due to  
bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per  
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal  
proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Myra Smith Glasby

in consideration of the said debt and sum of money  
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and  
also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before  
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,  
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said  
R. L. Batson, his heirs and assigns forever,

ALL that piece, parcel or lot of land in Butler Township, Greenville  
County, State of South Carolina, bounded on the norther by property  
of Charles Smith Henderson, on the South and East by a County Road and on  
the West by Thomas Crymes, and being shown as Tract No. 2 on a plat of  
property of Charles S. Henderson and Myra S. Glasby by J. Mac Richardson  
dated March 14, 1956 and being described in accordance with said plat  
as follows:

Beginning at an iron pin in the center of a County Road at the  
corner of property of Charles Smith Henderson and running thence with  
line of that property S. 89-47 W. 30 feet to an iron pin on the West  
side of road; thence still with the Henderson line, S. 89-47 W. 278  
feet to an iron pin at the corner of other property of Charles Smith  
Henderson; thence with that line, N. 46-00 W. 163 feet to an iron pin  
on line of Crymes land; thence with that line S. 27-34 W. 496.4 feet to  
an iron pin on the West side of a County Road; thence still S. 27-34  
W. 21 feet to a nail and cap in the center of said road; thence with the  
road, N. 62-19 E. 746 feet to the beginning corner, containing 2.5  
acres.
