Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the Southeast side of Yorkshire Drive (formerly known as Mable Avenue) near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 44 on plat of Property of James M. Edwards, made by Dalton & Neves, Engineers, March, 1954, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book EE, at Pages 60 and 61; said lot fronting 133.8 feet along the Southeast side of Yorkshire Drive, running back to a depth of 200.1 feet on the Northeast side of said lot along Cherokee Drive, to a depth of 200 feet on the Southwest side and being 139.6 across the rear.
