NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

ALL that certain piece, parcel or lot of land near the City of Greenville, and situate, lying and being on the East side of Hughes Road, being known and designated as Lot No. 9 on plat of Property of J. C. Hughes, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book SS at page 136, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern edge of Hughes Road, said iron pin being 275 feet South of the intersection of Hughes Road and Old Farris Bridge Road and running thence S. 74-57 E. 269.6 feet to an iron pin; thence S. 15-00 W. 100 feet to an iron pin; thence N. 74-21 W. 248.2 feet to an iron pin on the Eastern edge of Hughes Road; thence with said Hughes Road, N. 2-40 E. 100 feet to an iron pin, the point of BEGINNING.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever.
