LUTHI CONSTRUCTION CO. [INC.] (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Nine Thousand Three Hundred and No/100ths-----**
DOLLARS (\$ 9,300.00), with interest thereon from date at the rate of **six-----**
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the **Northeastern side of Renrick Street in the City of Greenville, County of Greenville, State of South Carolina, and having according to a plat prepared by C. C. Jones, dated December 9, 1963, entitled "Property of J. T. Collins" recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book EEE at page 145, the following metes and bounds:**

BEGINNING at an iron pin on the Northeastern side of Renrick Street which iron pin is located 113.5 feet in a Southeasterly direction from the Northeastern corner of the intersection of the Southern Railroad right of way and Renrick Street and running thence N. 34-34 E. 100 feet to an iron pin; thence S. 55-00 E. 75 feet to an iron pin; thence S. 34-34 W. 100 feet to an iron pin on the Northeastern side of Renrick Street; thence with the Northeastern side of Renrick Street N. 55-00 W. 75 feet to the point of beginning.

This is the identical property conveyed to the mortgagor herein by deed of J. T. Collins, dated July 7, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 755 at page 217.
