WHEREAS, the Mortgagor is well and truly indebted unto Aiken Loan & Security Company

, a corporation

if not sooner paid, shall be due and payable on the first day of February , 19 95.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina:

All that lot of land in the county of Greenville, State of South
Carolina, known and designated as Lot No. 7 as shown on plat of
property of J. A. Pittman & Maggie B. Pittman, made by Piedmont Engi-
neering Service, July 1958, recorded in Plat Book SS page 33, said lot
having a frontage of 95 feet on the north side of Pittman Circle, a
depth of 136.8 feet on the west side, a depth of 136.8 feet on the
east side and a rear width of 95 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

assigns forever.
