All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 9 on a plat entitled "Grahl Court" prepared by C. C. Jones, Engineer, dated July 1962, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book XX, at page 73 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Grahl Court at the joint front corner of Lots Nos. 9 and 10 and running thence with the line of Lot No. 10 N. 74-55 E. 175 feet to an iron pin; thence N. 15-05 W. 85 feet to an iron pin at the joint rear corner of Lots Nos. 8 and 9; thence with the line of Lot No. 8 S. 73-55 W. 160 feet to an iron pin on the Eastern side of Grahl Court; thence with the Eastern side of Grahl Court and with a curve, the chord of which is S. 3-22 W. 47.4 feet; thence continuing on the Eastern side of Grahl Court S. 15-05 E. 37 feet to the point of beginning.
