## FEB MORTGAGE OF REAL ESTATE

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of Lot 14 of property known as Sans Souci Highlands as

a portion of Lot 14 of property known as Sans Souci Highlands as shown by plat thereof recorded in Plat Book G at Page 126 and having according to a recent survey entitled Property of W. P. and Mary M. Hall, dated February 10, 1965, prepared by C. C. Jones, the following metes and bounds, to-wit:
