WHEREAS, the said Mortgagor(s) in and by her these Presents, is well and truly indebted to

All that certain parcel or lot of land containing 10 acres, more or less, situated on the west side of State Highway No. 101, between Greer and Gilreath's Mill, Oneal Township, Greenville County, State of South Carolina, and being Tract No. 1 of the property of the B.D. Smith Estate according to survey and plat by H.S. Brockman, Registered Surveyor, dated December 16, 1949, and having the following courses and distances, to-wit:
